Volltext	Anyone wishing to transport hazardous waste commercially requires a permit (transport permit). The permit is granted upon application by the competent authority and may be subject to conditions and obligations. The permit requirement on the territory of the Federal Republic of Germany also applies to the transboundary shipment of waste. A notification procedure does not replace a transport permit. For waste that is not classified as hazardous, a notification of commercial transport is required.

Voraussetzungen	
Kosten	The amount of the fees is determined - in accordance with Annex 1 to § 1 paragraph 1 of the General Fee Schedule of the State of Lower Saxony No. 2.1.37 - depending on the time spent. However, a minimum of EUR 50.00 and a maximum of EUR 2600.00 will be charged.

Hinweise	A company that is a waste management company in accordance with § 56 of the Closed Substance Cycle Management Act (KrWG) and is certified for the respective activity does not require a permit. Kurztext	Anyone wishing to transport hazardous waste commercially requires a permit (transport permit).
