Volltext	The organization of a traveling camp for the distribution of goods or services, which is to be referred to by public announcement, must be reported to the authority responsible for the location of the event. The competent authority may prohibit the organization of a hiking camp if the report is not made in a timely manner or is not truthful or not complete, or if the public announcement does not comply with the regulations. The hiking camp may only be managed on site by the organizers named in the advertisement or by a person authorized by them in writing.

This procedure can also be handled by a "Point of Single Contact".
