Kosten	Fees may apply, please contact the competent authority.
Verfahrensablauf	
Bearbeitungsdauer	
Frist	Slaughter must be notified to the competent authority in good time (at least 24 hours in advance). Emergency slaughter is to be considered separately from this, in any case the competent authority must be involved immediately.

Hinweise	Commercial slaughter may only be carried out in officially approved establishments.

- Farmed game.

The obligation to inspect also applies to domestic slaughter.
