These are countries that are not members of the European Union.</p> <p><b>**Transit**</b> refers to imported consignments which are subsequently re-exported. This means that they come from a third country and also go back to a third country.</p> <p>Before any introduction, import or transit, it should be clarified exactly which <b>**conditions**</b> must be fulfilled in order to prevent the animals or goods from being rejected at the border inspection post.</p> <p>Products and products that may be confused with foodstuffs which do not comply with the laws applicable in Germany, except</p> <ul style="list-style-type: none"> <li>• foodstuffs intended exclusively for scientific purposes, trade fairs, exhibitions or similar events,</li> <li>• food samples and samples in small quantities,</li> </ul> <p>may not be brought into the country.
