Volltext	<p>If you are not in possession of a corresponding permit in accordance with the Explosives Act, you may only handle or deal with explosive substances requiring a permit as a responsible person if you are in possession of an official certificate of competence for handling and/or dealing with explosive substances in accordance with the Explosives Act.</p> <p>Responsible persons or supervisors include, in particular, managers of an operating department, authorized blasters, foremen, technical supervisory personnel in explosive ordnance disposal and warehouse managers as well as persons who are authorized to move explosive substances, to transfer them to others or to receive them from others. to others or to receive these substances from others.</p> <p>A certificate of competence for the handling and/or transportation of explosive substances is only issued to natural persons.</p> <p>As an applicant, you will generally receive a certificate of competence for the handling and/or transportation of explosive substances in accordance with the Explosives Act if you are</p>

However, only persons who can present a clearance certificate may take part in such a course.</p> <p>The certificate of competence for handling and/or dealing with explosive substances in accordance with the Explosives Act is only issued on application and generally for a period of five years. It can be restricted in terms of content, limited in time and, even retrospectively, subject to conditions.</p>

	<p>check whether all requirements for issuing the certificate of competence have been met.</p> <p>If all documents are complete, you will receive the requested certificate of competence.</p>
Bearbeitungsdauer	If the documents are complete, your application will be processed promptly.
Frist	The certificate of competence is generally issued for a period of five years. For an extension of the certificate of competence, a refresher course must be taken if the applicant continues to be reliable. The application must be submitted in good time, at the latest 8-10 weeks before the intended commencement of an activity covered by the SprengG. The clearance certificate must not be older than one year.

Hinweise	<p>The certificate of competence entitles the holder to work for a company with a permit under the Explosives Act.</p> <p>If the qualified person wishes to work independently, an application must be made for a permit under the Explosives Act.</p>
Rechtsbehelf	Appeal (appeal may be excluded depending on national law), administrative court action

own supervisory area, the Celle Trade Supervisory Office is also responsible for the supervisory areas of the Cuxhaven and Lüneburg Trade Supervisory Offices in matters relating to explosives law; the Osnabrück Trade Supervisory Office is also responsible for the supervisory areas of the Emden and Oldenburg Trade Supervisory Offices in addition to its own supervisory area. All other trade supervisory offices are responsible for explosives law in their own supervisory area.
