Notaries as well as the Notarial Fund for the vocational
training of specialists in the field of administration of
justice,
• the Chamber of Auditors and the Chamber of Tax

the field of auditing and tax consulting,
• the Chamber of Doctors, Dentists, Veterinarians and
Pharmacists for the vocational training of specialists in
the health professions.

Further responsibilities, e.g. for bodies under public
law as well as for churches and other religious
communities, are regulated in the Vocational Training
Act (BBiG).
