Volltext	<p>Permit to operate an amusement arcade or similar business in accordance with Section 33i of the Trade Regulation Act (GewO) as well as a permit for the establishment and operation of an amusement arcade in accordance with Section 2 of the Brandenburg Amusement Arcades Act (BbgSpielhG).</p> <p>Anyone wishing to commercially operate a gaming arcade or a similar business that is exclusively or predominantly dedicated to the installation of gaming devices or the organization of other games within the meaning of Section 33c para. 1 sentence 1 or § 33d para. 1 sentence 1 GewO requires the respective license from the competent authority.</p>
