Teaser	Which catering establishments are considered "temporary", when and under what circumstances do they have to be reported?
Volltext	<p>A temporary catering business is carried on by a person who, on a commercial basis, for consumption on the spot,</p> <ul style="list-style-type: none"> <li>• drinks and/or</li> <li>• prepared food,</li> </ul> <p>if the restaurant is accessible to everyone or certain groups of people and is only operated temporarily for a specific occasion, such as a festival, anniversary or other occasion.</p> <p>Anyone wishing to temporarily operate a catering business on a case-by-case basis must notify the competent authority for the place concerned in accordance with Section 2 (2) of the BbgGastG in writing two weeks before the start of the event using the form in accordance with the annex to Section 2 (2) of the BbgGastG (Notification of a Temporary Catering Business - Gagev).</p> <p>This notification shall also state that:</p> <ul style="list-style-type: none"> <li>• which mode of operation it is, and</li> <li>• whether it is intended to offer alcoholic beverages.</li> </ul> <p>The following operating modes can be considered:</p> <ul style="list-style-type: none"> <li>• Snack</li> <li>• Public house</li> <li>• Dining</li> <li>• Tavern and Dining</li> </ul>

	<ul style="list-style-type: none"> <li>• Outdoor bar area (beer garden)</li> <li>• Café</li> <li>• Bar</li> <li>• with musical performance</li> <li>• with dance event</li> <li>• Ostrich farming</li> </ul>
Erforderliche Unterlagen	<ul style="list-style-type: none"> <li>• The notification is made on the "Gagev" form</li> <li>• Identity card or passport for identification</li> <li>• Foreigners who are not citizens of an EU member state or an EEA member state require a residence permit from the competent immigration authority, according to which they are permitted to exercise the trade under aliens law</li> </ul>
Voraussetzungen	The notification must be made both for the serving of alcoholic and/or non-alcoholic beverages and for the administration of food during temporary activities, such as club parties.
Kosten	Certificate of receipt of the notification of a temporary catering business: € 32.00 in accordance with the Ordinance on Administrative Fees in the Portfolio of the Minister of Economy, Labour and Energy (MWAEGebO)
Verfahrensablauf	<p>The notification must be submitted to the competent authority two weeks before the start of operations.</p> <p>The following authorities are involved by the Trade Authority:</p> <ul style="list-style-type: none"> <li>• Food Inspection Authority</li> <li>• Lower Building Inspectorate</li> <li>• Environmental area of independent cities, municipalities and offices</li> <li>• Tax office</li> </ul>

Zuständige Stelle	<p>Local regulatory authorities according to § 1 BbgGastGZV.</p> <p>The tasks of the local regulatory authorities are performed by the offices, the municipalities that are not subject to administrative authority, the association municipalities, the municipalities that are co-administered, the municipalities that are co-administered and the independent cities (§ 3 of the Regulatory Authorities Act – OBG)</p> <p>This procedure can also be carried out through a "Point of Single Contact". The "Point of Single Contact" is a special service offered by the municipalities and the state for service providers.</p>
