Volltext	The appointment as a tax consultant in accordance with § 40 StBerG takes place after passing the tax consultant examination or after exemption from the tax consultant examination upon application by the responsible Chamber of Tax Consultants.

The application must be accompanied by:

- a certified copy of the certificate issued by the competent authority confirming that the tax consultant examination has been successfully passed or that the tax consultant has been exempted from this examination
  - a passport photo
  - Proof of professional indemnity insurance

For candidates who have been exempted from the exam:

- a statement as to whether disciplinary action has been imposed on him within the last twelve months

and whether disciplinary investigations are pending against him or have been pending within the last twelve months

For candidates who are lawyers, European lawyers in private practice, chartered accountants or chartered accountants:

- Certificate from the professional organisation or other competent body responsible for him that no facts are known that justify the withdrawal or revocation of the authorisation or appointment or the initiation of professional court proceedings against him

Proof of payment of the order fee

**Voraussetzungen**

- Passing the tax consultant exam or exemption from the tax consultant exam
  - Proof of the existence of professional indemnity insurance
  - Certificate of good conduct of document type O (according to § 30 para. 5 BZRG)

**Verfahrensablauf**

The application for appointment or reappointment as a tax advisor must be submitted to the locally competent Chamber of Tax Advisors according to the officially prescribed form.

- Transfer of the order fee/reappointment fee
- Submission of the required documents to the Brandenburg Chamber of Tax Advisors
  - checking the documents submitted and the information provided by the applicant for completeness and accuracy; If necessary, further investigations before the decision on the order is made
- Arrangement of an order appointment
- Order and handing over of the certificate of
