| Volltext                   | <p>Compulsory schooling in Brandenburg begins for all children in the year in which they reach the age of six by September 30. If your child turns six between October 1 and December 31 and you would like your child to start school in this year, please submit an application to the relevant school as part of the school registration process.</p> <p>As a rule, the application must be submitted by the end of February at the responsible elementary school. The specific day is announced each year. The elementary school responsible is determined by the school district statutes of the respective school authority. If congruent school districts have been established for a place of residence, you register your child at the school of your choice. To register, the child be presented in person at the school. Proof of participation in the language assessment (in the daycare center) and proof of sufficient vaccination protection or immunity against measles or a medical contraindication against a measles vaccination must be presented when registering at the school.</p> <p>In justified exceptional cases, children who reach the age of six after December 31 but before August 1 of the following year may also be admitted to the school on August 1.</p> |
