Teaser	Recognition of previous vocational training by competent authorities
Volltext	According to the Vocational Training Act (BBiG), the federal states can regulate the crediting of prior vocational training. After consulting the State Committee for Vocational Education and Training, the state governments can determine by statutory order that attendance of a course at vocational schools or vocational training in another institution is credited in full or in part towards the training period. A joint application by the trainee and the training provider is mandatory for crediting. The application must be submitted to the competent body (e.g. the relevant chamber). It may be limited to parts of the maximum permissible crediting period.

If there are no chambers for individual occupational areas, regulations are already laid down in the state law that relate to responsibility. In addition, chambers can agree a special allocation of responsibilities among themselves with the approval of the competent supreme federal or state authority.</p>
