Teaser	You can apply for an extension of your residence permit to pursue an occupation in which there is a public interest, in particular a regional, economic or labor market policy interest, if its validity is about to expire.
Volltext	The residence permit for employment in which there is a public interest, in particular a regional, economic or labor market policy interest, is issued for a limited period. It can be extended if the employment is to be continued beyond the period of validity of your residence permit. Apply for an extension of your residence permit at least eight weeks before the expiry date at the

immigration office responsible for your place of residence.

The same conditions apply for the extension as for the issue. In particular, there should still be a public interest in your employment. A public interest in employment can be justified, for example

if there is a regional or supra-regional public interest in the products or services of an employer or if there is a shortage of certain goods or services at the employer's location (regional interests). Supply or municipal policy reasons may also play a role here.
if substantial investments and/or a significant number of jobs are created or secured; if the establishment of the company is associated with a sustainable improvement in the sales or market opportunities of domestic companies or if it involves the establishment of a production plant for technically high-quality (future-proof) and/or particularly environmentally friendly products (economic interests).
if the employment maintains or creates jobs (labor market policy interests).

The private economic, operational interest of an employer alone is not sufficient to justify a public interest in employment.

Your qualifications are not decisive for the extension of your residence permit.

The Federal Employment Agency approved your residence permit when it was first issued. If the validity of the approval has expired, it must be granted again for the extension of your residence permit.

You may have been obliged to take part in an integration course when your residence permit was first issued. If this is the case, this must be taken into account when extending your residence permit. If you have not yet taken part in an integration course, the immigration authority may reject your application to extend your residence permit. If you have not yet completed the integration course, the residence permit will generally only be extended for one year at a time

	until you successfully complete it or provide proof that you have been integrated into society and social life in another way.
	If your residence permit is extended, it will be limited in time again. The duration of the time limit depends on the duration of your employment contract or the period of validity of the approval of the Federal Employment Agency.
	As a rule, the residence permit cannot be extended if this was already ruled out when the residence permit was issued or last extended.

Voraussetzungen	<ul> <li>You have a recognized and valid passport or passport substitute and a valid residence permit for employment in the public interest.</li> <li>Your residence permit will expire in the near future.</li> <li>There is no interest in deporting you.</li> <li>Your stay does not jeopardize or impair the interests of the Federal Republic of Germany.</li> <li>You have a new employment contract or a new binding job offer with the same or another employer.</li> <li>There is still a public interest in your employment, in particular a regional, economic or labor market policy interest.</li> <li>You can continue to secure your livelihood and health insurance cover independently without claiming public benefits.</li> <li>You have the approval of the Federal Employment Agency to take up employment or this has been renewed (approval is usually obtained from the immigration authority). To obtain approval, your working conditions (in particular salary) must be comparable to those of a German employee in the</li> </ul>

	<ul> <li>for a further stay of up to three months: EUR 96</li> <li>for a further stay of more than three months: EUR 93</li> </ul>
	Under certain conditions, a fee reduction or fee exemption may be possible.
	Note: The residence permit in the form of the electronic residence permit must be reissued for the extension. The fee for reissuing the card body is EUR 67.00.
Verfahrensablauf	You must apply for an extension of your residence permit at the foreigners authority responsible for your place of residence. The procedure is as follows:
	<ul> <li>Depending on the foreigners authority and your request, it may be possible to apply via the Internet. Find out whether your foreigners authority offers electronic application for a residence permit.</li> <li>If you can only apply in person, make an appointment with the immigration office.</li> <li>During the appointment, your application will be accepted and your supporting documents checked (bring these with you to the appointment). Your fingerprints will be taken for the renewal of the electronic residence permit (eAT card).</li> <li>In the case of an electronic application, the Immigration Office. Kurztext	<ul> <li>Residence permit for the purpose of gainful employment Extension for the purpose of employment in the public interest</li> <li>The residence permit for employment on the basis of a public interest, in particular a regional, economic or labor market policy interest, can be extended if the temporary residence permit expires and the employment is to be continued.</li> <li>The extension must be applied for at least eight weeks before the temporary residence permit expires.</li> <li>The same conditions apply for the extension as for the issue.</li> <li>If the period of validity of the approval obtained when the residence permit was issued has expired, the approval of the Federal Employment Agency must be obtained again.</li> <li>If the obligation to attend an integration course was stated when the residence permit was issued, proof must be provided that this obligation has been fulfilled. If the integration course has not yet been completed,</li> </ul>

	<ul> <li>the foreigners authority can refuse to extend the residence permit or only extend it for one year until the course has been successfully completed or proof has been provided that integration into society and social life has taken place in another way.</li> <li>In the course of the extension, the residence permit is again limited in time.</li> <li>An extension is excluded if this was already ruled out by the immigration authority when the permit was issued or when it was last extended.</li> <li>Depending on the foreigners authority and your request, you can apply online or in person.</li> <li>Fees are charged for the extension. The time and form of payment vary depending on the authority.</li> <li>Responsible: the foreigners authority responsible for the applicant's place of residence</li> </ul>
