Volltext	Anyone wishing to operate a restaurant must notify the competent authority in writing four weeks before the start of the business. In addition, he must register a business.
Erforderliche Unterlagen	The notification must indicate the surname, first name and address of the operator, the place and time of commencement of operations, the type of beverages and food intended for sale and the mode of operation. In addition, it must be indicated whether it is intended to offer alcoholic beverages. If alcoholic beverages are served, further documents must be submitted. • Proof of applied for certificate of good conduct • Proof of requested information from the Central Trade Register for submission to the authority • Certificate of good standing for tax purposes

Frist	Four weeks before the start of operations, the competent authority must be notified in writing.

Hinweise	The notification obligation applies accordingly to the operation of branches, a dependent branch, the relocation of the permanent establishment, the expansion of the range of services and the discontinuation of the business. Changes to the notification made must be notified to the competent authority in writing without delay.
