- Geriatric psychiatry

Training centers that wish to offer state-regulated further training in these areas require state recognition. They are subject to state supervision in order to ensure the ongoing quality of further training.

## Erforderliche Unterlagen

- Professional certificates and further training certificates of the management and teaching staff (copies)
- Information about the premises in which you would like to set up the training center (e.g. rental agreement or other planning documents)
- Cooperation agreements with institutions where the practical training components will take place
  - Teaching and timetables
  - Professional assignment of the lecturers and practical instructors on site
  - Type and implementation of the required performance records
  - Form of communication with the practical instructors on site

- They have enough qualified management and teaching staff.
- Your rooms are large enough.
- Your rooms are equipped with the appropriate teaching and learning materials.
  - with a suitable hospital,
  - an outpatient care service or
  - a facility for the elderly or disabled and

- the qualification of the practical instructors on site
- You must provide evidence of the following in order to ensure practical professional development:
