Volltext	Many healthcare professionals decide to set up their own practice. This applies to the medical and healthcare professions, such as: • alternative practitioners (limited to the field of psychotherapy/physiotherapy) • Nurses and pediatric nurses • Midwives and maternity assistants • geriatric nursing • Physiotherapy, physiotherapy • Masseurs and masseuses • Medical bath attendants and bath attendants • Speech therapy • Occupational therapy, occupational therapy and work therapy • Orthoptics The following applies to all professional groups in the healthcare sector: If you wish to practice your profession independently, you must notify the responsible health authority immediately. Immediate notification to your local health authority is also necessary in the following cases: • You employ healthcare professionals. • You offer or provide nursing and care for the elderly

Verfahrensablauf	A notification, for example to register a medical practice, must be made in writing: • Ask your local health authority whether a notification form is available. • Submit the notification (the completed form, if applicable) together with the necessary supporting documents to your local health authority. • Otherwise, please contact your local health authority.
