Teaser	After your foreign professional qualification has been recognised, you can be granted a residence permit to take up a corresponding employment relationship or self-employment for a maximum of 12 months.
Volltext	If the equivalence of your foreign professional qualification has been established or you have received the professional practice permit, you can be granted a temporary residence permit to look for a job or take up self-employment directly following your previous recognition procedure. This residence permit allows you to work without restrictions.
Erforderliche Unterlagen	• Valid national passport • Proof of a secure livelihood (e.g. employment contract and pay slips, bank statements, submission of a declaration of commitment by a third party) • Proof of health insurance • Proof of qualification (diploma, certificate or

	attestation from your training company or educational institution confirming successful completion of training) • 1 current biometric photo • Please enquire at the foreigners authority responsible for you whether you need to submit further documents.
Voraussetzungen	You already have a residence permit for the purpose of the recognition procedure of a foreign professional qualification in the Federal territory. The further general conditions for the granting of a residence permit are in particular: • a secure livelihood, • a clarified identity, • possession of a valid national passport.
Kosten	Gebühr: 98€
Verfahrensablauf	You can only apply for a residence permit in person at the aliens' registration office responsible for your place of residence. • You submit the required documents in the original and pay the application fee. • The Aliens' Registration Office will check whether the conditions for issuing the permit are met. • If all requirements are met, the Aliens' Registration Office will take your biometric data (photo, fingerprints) and order the electronic residence permit (eAT) from Bundesdruckerei GmbH. • As soon as the eAT is ready, it will be handed over to you by the Aliens' Registration Office.
Bearbeitungsdauer	The processing time depends on the workload at the locally responsible foreigners authority.
Frist	Application before expiry of the current residence permit. It is recommended to apply 4 to 6 weeks before the current residence permit expires. The residence permit is limited to a maximum of 12 months.
