| Volltext                      | If the electoral roll for the European elections contains incorrect information or is incomplete, you can have this corrected. From the 20th day before the election (= start of the inspection period), this is only possible on the basis of an objection or ex officio. The objection is only possible until the 16th day before the election (= end of the inspection period). It must be submitted in writing or recorded in writing to the municipality of residence. The municipality decides on the objection up to the 10th day before the election. An appeal against the decision is possible within two days of notification. The municipality may correct the electoral roll at any time if it is obviously incorrect or incomplete. The electoral roll is closed no later than the day before the election. |
