Volltext	The driving licence for the carriage of passengers (FzF) for ambulances is issued for a maximum of five years and can be extended for up to five years at the holder's request. Caution: If the application is submitted after the expiry of the FzF, renewal is no longer possible. The issuance of a new FzF must be applied for.
