| Volltext                         | If you have successfully completed your studies at a state or state-recognized university or comparable educational institution in the Federal Republic of Germany, or if you hold a residence permit as a researcher or scientist, you may apply for a residence permit to pursue self-employment.<br>The prerequisite for university graduates is the successful completion of the course of study that qualifies them for self-employment. Your intended self-employed activity must therefore be related to the knowledge you acquired during your university education.<br>If you are in possession of a residence permit as a researcher or scientist, the intended self-employed activity must show a connection with your previous activity as a researcher or scientist. |

| Erforderliche Unterlagen | <ul> <li>Recognized and valid identity document (for example passport or passport substitute)</li> <li>Visa, if required for entry into the country</li> <li>Recent biometric photo in passport format (45 x 35 mm)</li> <li>For university graduates: Proof of graduation from a state-recognized university or comparable educational institution in Germany</li> <li>For scientists and researchers: previous employment contract</li> <li>Proof of livelihood security (e.g. equity capital, blocked account, declaration of commitment)</li> <li>Proof of health insurance coverage</li> <li>Current certificate of registration</li> <li>After reaching the age of 45: proof of adequate pension provision (e.g. proof of own assets, acquired pension entitlements, company assets)</li> </ul> |

| Verfahrensablauf                | <ul> <li>Find out whether your foreigners authority allows you to apply online or has a special application form.</li> <li>If the application can only be submitted in person, make an appointment at the Aliens' Registration Office. In the case of online application, the Aliens' Registration Office will contact you after receiving your application to schedule an appointment.</li> <li>During the appointment, your identity and documents will be checked (please bring your documents, if possible in original, to the appointment).</li> <li>If your application is granted, your fingerprints will be taken for the production of a new electronic residence permit (eATKarte). The Aliens' Registration Office will order the production of the eAT card from the Bundesdruckerei. After completion, you will receive information and can pick up the residence permit at the responsible office. The eAT card must always be collected in person.</li> <li>If your application is rejected, you will receive a rejection notice.</li> </ul> |

| Hinweise          | <ul> <li>The granting of the residence permit is at the discretion of the foreigners authority.</li> <li>Self-employed activity is any self-employed, permitted, profit-making activity of a certain duration, provided it is not an employment relationship.</li> <li>Scientists are persons who belong to the scientific community, i.e. essentially the scientific staff of universities and research institutions. Researchers also fall under the definition of scientist.</li> <li>Holders of a residence permit can obtain an unlimited right of residence (settlement permit) under eased conditions after only three years of successful self-employment.</li> </ul>  |
| Rechtsbehelf      | <ul> <li>Appeal against the decision of the Foreigners'<br/>Registration Office</li> <li>Action before the court named in the notice of appeal<br/>if the appeal is not granted</li> </ul>   |
| Kurztext          | <ul> <li>Residence permit for the purpose of gainful<br/>employment Issuance to self-employed persons who<br/>have completed studies or who have been scientists<br/>and researchers.</li> <li>Residence permit for the purpose of self-employment<br/>can be granted to foreign persons under facilitated<br/>conditions, who have obtained their university degree<br/>in Germany at a state or state-recognized university or<br/>comparable educational institution, or who hold a<br/>residence permit as a researcher or scientist.</li> <li>The intended self-employed activity must show a<br/>connection with the knowledge acquired in the<br/>university education or the previous activity as a<br/>researcher or scientist.</li> <li>Residence permit is limited to a maximum of three<br/>years.</li> <li>Responsible: the foreigners authority responsible for<br/>the applicant's place of residence.</li> </ul> |
