# Modul Sachverhalt

- are in intensive social-pedagogical individual care
- live as a mentally handicapped child or young person in a foster family or in an in-patient child and youth welfare facility
- have been taken into care (also temporarily) by the youth welfare office
- are accommodated in a socio-educationally accompanied form of accommodation while participating in school or vocational training measures or during vocational integration

### mothers or fathers who

• have sole responsibility for a child under the age of six and live with the child in a shared form of accommodation for mothers/fathers/children, and

### children who

• live with their mother or father in shared accommodation for mothers/fathers and their children

## Erforderliche Unterlagen

• A separate application is not required. In order to check the entitlement, the Youth Welfare Office requests the necessary documents in each case.

# Voraussetzungen

# Sickness assistance can be given to

- Children, adolescents or young adults who live in a foster family or in an inpatient child and youth welfare facility ("children's home").
- Children and young people who have been (temporarily) taken into care by the youth welfare office,
- young people who are living in a socio-educationally accompanied form of accommodation while participating in school or vocational training measures or during vocational integration.
- Mothers or fathers caring alone for a child under six years of age and living with the child in a shared mother/father/child living arrangement.
- Children living with their mother or father in a shared living arrangement for mothers/fathers and children.

	<ul> <li>Health assistance is only granted if there is no other health insurance cover or if this does not fully cover the necessary needs.</li> <li>The legal guardians or the child or the adolescent or the young adult have a claim.</li> </ul>
Kosten	There are no fees.
Verfahrensablauf	<ul> <li>The competent youth welfare office checks whether health insurance cover exists elsewhere, for example via family insurance or voluntary continued insurance.</li> <li>If there is no priority option for health care or health insurance, the youth welfare office ensures health care (for example by registering with a statutory health insurance fund).</li> </ul>
