Teaser	Do you want to transport passengers commercially in a cab? You can apply for the necessary permit from the relevant transport authority.
Volltext	You require a permit for the commercial transportation of passengers by cab. You can submit a corresponding application to your local transport authority in the respective independent city or district.
Erforderliche Unterlagen	<ul style="list-style-type: none"> • Formal application (surname, first name of the applicant; place of residence and place of business; for natural persons: Date of birth, place of birth; number of vehicles, vehicle type, capacity of the vehicles to be used) • Certificates of employment or examination certificates (for professional suitability) of the applicant or the person appointed to manage the business • Equity certificate / additional certificate (form in accordance with Section 2 (2) No. 2 / Section 2 (3) of the Professional Access Ordinance for Road Passenger Transport PBZugV), not older than 12 months • Clearance certificate from the tax office, the municipality, the social insurance institution and the employers' liability insurance association, not older than 3 months (from the company, the legal representative and the person appointed to manage the business / transport management) • Certificate of good conduct for submission to the authorities in accordance with Section 30 (5) BZRG • Extract from the central trade register in accordance with Section 150 (5) GewO (for companies)

Voraussetzungen	<ul style="list-style-type: none"> • The safety and efficiency of the business is guaranteed. • There are no facts indicating that the applicant is unreliable as an entrepreneur or the person appointed to manage the business. • The applicant as entrepreneur or the person appointed to manage the business is professionally qualified. • The applicant and the entrepreneurs appointed by the applicant to provide transport services must have their registered office or place of business within the meaning of commercial law in Germany. <p>New applicants and existing entrepreneurs must be given appropriate consideration. Within both groups, consideration will be given according to the chronological order in which applications are submitted.</p> <ul style="list-style-type: none"> • who do not intend to operate a cab business as their main occupation, • have not operated their cab business as their main occupation or have sold or leased it in whole or in part within the last 8 years, • has not properly fulfilled his or her operating obligations <p>An applicant may only be granted one permit at a time, provided that no more permits can be granted than there are applicants.</p>

	<p>commercial transportation of passengers by cab:</p> <ul style="list-style-type: none"> • Submit a corresponding application to the transport authority responsible for you in the respective independent city or district and enclose all the necessary documents with the application. • The authority will process your application and carry out the necessary hearing procedures. • You will receive a decision on the issue or re-issue of a cab permit, including the handover of the permit certificates.
Bearbeitungsdauer	The processing time may vary between the competent transport authorities. The processing time may depend, among other things, on whether all documents relevant to the decision have been submitted or whether additional requests for documents are necessary.
Frist	Deadlines only start to run once a decision has been made on the application. If your application is complete, a decision will be made within 3 months. The deadline can be extended by 3 months if necessary. The general objection period under administrative procedure law is one month.
