Among other things, you can • exercise your right to vote in the federal states and for the German Bundestag, • enjoy freedom of movement within the European
	 Union as a citizen of the Union, and can also travel outside Europe to many countries without a visa. If you have been stateless since birth in Germany, you are entitled to acquire German citizenship through

	If you are being investigated on suspicion of a criminal offense, the naturalization procedure remains suspended until the conclusion of the proceedings.
	The naturalization becomes effective by delivery of the naturalization certificate. The competent authority is the citizenship authority of your place of residence.
Erforderliche Unterlagen	 valid travel document for stateless persons valid residence permit birth certificate for persons under 16 years of age: Proof of legal representation in case of joint parental care of the parents only declaration of consent of the other parent with custody rights
Voraussetzungen	 You must apply for naturalization before your 21st birthday. You must be at least 16 years old or be legally represented. You have been stateless since birth. You were born in Germany. You have resided legally and permanently in Germany for at least 5 years. You have not been sentenced to a custodial or juvenile sentence of more than 5 years. You are not being investigated on suspicion of a criminal offense. If you have, the naturalization procedure remains suspended until the criminal proceedings have been completed.

Verfahrensablauf	You can submit your application for naturalization in writing to the relevant office:
	 Fill out the application completely and submit it by mail with the required documents. The competent office will review your application and decide whether you meet the requirements for naturalization. If you meet the requirements, you will finally receive a naturalization certificate. With this certificate you acquire German citizenship.
