Teaser	If you already have a driver's license, you can upgrade it to a Class B driver's license.
Volltext	With the class B driver's license, you can drive motor vehicles that have a maximum permissible total mass of 3.5 t and are designed on site for no more than 8 people (in addition to the driver's seat). You can transport trailers weighing less than 750 kg with the class B driver's license. If the total mass of the vehicle combination is maximum 3.5 t, the trailer may also weigh more than 750 kg. The class B driving license is issued for an unlimited period of time.
Erforderliche Unterlagen	• valid identity card or passport (if necessary with current certificate of residence) • Application for the extension of the driving license • a biometric photo according to the passport regulation (size 45x35 mm) • eye test certificate (not older than two years) • proof of training in first aid (if not already proven to the driving license authority) • valid driver's license • if necessary, a copy of the card from the last issuing authority (if different) • Information about the driving school
Voraussetzungen	• You must be in possession of a driving license class. • You must have your main residence in the Federal Republic of Germany. • The minimum age is 18 years. You can apply for the extension of the driving license at the earliest 6 months before reaching the minimum age.

Kosten	The fee is based on the applicable schedule of fees for road traffic measures (GebOSt). If the driver's license is sent directly to the home address, an additional shipping fee will be charged.

Frist	The practical test must be taken within 12 months of passing the theoretical test. Otherwise, the theoretical exam loses its validity.

Hinweise	If a driver's license in classes AM, L or T is extended to another class for the first time, a probationary period is set for the new class.

Kurztext	• Driving license extension by class B • applicant can extend the existing driving license by class B • permitted vehicles: motor vehicles (except motorcycles) • up to 3500 kg maximum permissible mass (zGM) • with up to 8 seats (in addition to the driver's seat) • also with trailer (maximum permissible mass of the trailer: 750 kg) • also with heavier trailer, if the combination does not exceed 3500 kg • responsible: competent driver licensing authority
