| Teaser                           | When your new ID card is available, you can pick it up in person. Collection by an authorized person is also possible.   |
| Volltext                         | You usually pick up your ID card at the Bürgeramt<br>where you applied for it. You can also authorize a<br>representative to collect the ID card with a power of<br>attorney that also contains instructions on how to<br>obtain the PIN letter.   |
|                                  | If you have not received a PIN letter, you can only pick<br>it up in person and not with a proxy.  |
|                                  | Only this Bürgeramt can tell you whether you need to<br>make an appointment to pick up your ID card or<br>whether you need to follow any other instructions<br>regarding the time of pickup.   |
|                                  | The PIN letter will be sent directly to your registration<br>address. If you do not have a residential address in<br>Germany, the PIN letter can also be sent to the issuing<br>Bürgeramt. In this case, you will receive the PIN letter<br>there on the day you pick up your new ID card. |
|                                  | The PIN letter contains a five-digit transport PIN, an<br>unblocking number (PUK) and a blocking password.<br>You can use the transport PIN to set a six-digit PIN of<br>your own choice. You need this six-digit PIN to identify<br>yourself online with your ID card.                    |
|                                  | You can hand in your old ID card when you pick it up,<br>or you can have it cancelled if you want to keep it as a  |

| Erforderliche Unterlagen | <ul> <li>Your old identity card document (exception: old identity card is no longer available due to loss/theft).</li> <li>In case of representation: power of attorney for the collection of an identity card</li> </ul>  |
| Voraussetzungen          | The new ID card is ready for collection at the citizen's office where the ID card was applied for.   |
| Kosten                   | There are no costs involved.   |
| Verfahrensablauf         | <ul> <li>You can pick up your new ID card at the Bürgeramt where you applied for it:</li> <li>Before you can pick up your new ID card, the PIN letter is usually sent to your registration address. In the PIN letter, you will find the transport PIN and a blocking password. In exceptional cases, the PIN letter can be sent directly to the Bürgeramt.</li> <li>You can find out when the ID card can be picked up when you apply or ask at the Bürgeramt. If you have not received a PIN letter, you can still pick up your ID card if you assign a six-digit PIN of your own choice directly when you pick it up.</li> <li>You pick up your new ID card at the Bürgeramt where you applied for it.</li> <li>You will find out whether you need to make an appointment to pick it up when you apply, or you can ask at the Bürgeramt.</li> <li>Upon presentation of your old ID card, the new ID card will be handed over to you. If you would like to keep the old ID card as a souvenir, the document can be returned to you invalidated.</li> <li>If you have lost your old ID card, you must explain to the authorities whether you have received the PIN letter and confirm this with a signature.</li> </ul> |

|                                 | <ul> <li>If the PIN letter was sent directly to the Citizens'<br/>Registration Office, the PIN letter will be given to you<br/>there. You confirm receipt with a signature.</li> <li>You will be informed about the online ID card<br/>function by the authority staff.</li> <li>When you receive your new ID card, you have the<br/>option of assigning a six-digit PIN of your own choice<br/>and thus making the online ID card function (online ID<br/>card) immediately ready for use. You can also set the<br/>six-digit PIN yourself at any time and at home using,<br/>among other things, a suitable NFC-enabled<br/>smartphone as well as the PIN letter and the ID card<br/>app2.</li> <li>If you have not received the PIN letter and it has not<br/>been sent to the ID card authority, you must - if you<br/>wish to receive the ID card - set a six-digit PIN of your<br/>own choice and you will be given the blocking<br/>password by the authority staff. Otherwise, a fee-free<br/>reclamation order will be initiated.</li> <li>Finally, you confirm receipt of the new ID card with<br/>your signature.</li> <li>An authorized adult person can be entrusted with the<br/>collection. This person must identify himself/herself<br/>and submit a written authorization for collection with<br/>the following additional statement: "PIN letter<br/>received". You can find a form for this authorization<br/>online on the ID card portal.</li> </ul> |
