Volltext	If you want to cut down a protected tree on your public or private property, cut it back severely or interfere with the root system (e.g. excavation, backfilling, root separation), you will need a special permit. Measures on protected trees are generally subject to conditions. These include the period of the approved measures as well as statements on replacement planting (tree species, number of trees, tree quality) or the payment of a compensatory levy. The respective tree protection statutes of the municipalities are decisive in detail
