Teaser	The approval of private inspection bodies, their monitoring and the withdrawal of approval are the responsibility of the State Agency for Agriculture.
Volltext	The Bavarian State Institute for Agriculture (LfL) provides information on the necessary application and the requirements for approval as an inspection body for compliance with the specifications in the areas of protected geographical indication (PGI), protected designation of origin (PDO) and traditional specialty guaranteed (TSG). It accepts the application and grants approval if necessary. The approval is the basis for the inspection body's activities (carrying out on-site inspections at the producer's premises) and is granted for a limited period of time.
