Teaser	Only state-recognized test centers for measuring devices for gas, water, heat or electricity may calibrate these measuring devices. Private companies can apply for recognition as a test center.
Volltext	<p>Upon application, the Bavarian State Office for Weights and Measures may authorize private companies to calibrate measuring instruments for gas, water, heat and electricity for the utility industry in accordance with the Verification Act and the Verification Ordinance.</p> <p>For this purpose, the company must provide and maintain test rooms, test stands and test center personnel in accordance with the calibration regulations.</p> <p>In the recognition procedure, the Bavarian State Office for Weights and Measures checks compliance with the requirements. With a certificate of recognition and a final operating license, as well as after public appointment and commitment of the leading test centre personnel, the test centre is authorized to carry out verifications.</p>

- The applicant (body responsible for the inspection body) must offer the assurance that the body responsible for the inspection body is entered in the commercial register he is able to compensate the damage due to his liability arising from breaches of official duty by the staff of the Enforcement Panel (proof of liability insurance is required) he/she can raise sufficient funds for the maintenance and proper operation of the inspection body

## Voraussetzungen

The test body must have suitable test rooms,  
 recognized test equipment and competent personnel  
 in accordance with § 43 MessEV.

## Kosten

The following costs are calculated in accordance with  
 the calibration costs ordinance:

- Recognition costs depending on the expected scope of testing per year: approx. 1980 to 4620 EUR
- For the expert examination of the test center personnel in charge: 243 EUR per person
- For the appointment and commitment of the lead inspection body personnel: EUR 96 per person
- For ongoing monitoring, depending on the number of measuring devices tested: EUR 1650 to 6270 per year

Verfahrensablauf	<p>The Bavarian State Office for Weights and Measures must be applied for recognition as a test center for the performance of verifications.</p> <p>The Bavarian State Office for Weights and Measures verifies that the requirements are met.</p> <p>With a certificate of recognition and a final operating license, and after public appointment and commitment of the leading testing laboratory personnel, the testing laboratory is authorized to carry out verifications.</p>
Bearbeitungsdauer	
Frist	<p>The accreditations of the inspection bodies that were issued until 31.12.2014 in accordance with the (old) verification regulations have retained their validity until 31.12.2016 at the latest. All inspection bodies that wish to continue operating in this field must apply for new recognition.</p>
