Teaser	Recognition of a training event in accordance with Section 5 (2) sentence 1 ChemOzonSchichtV is granted by the Bavarian State Office for the Environment after reviewing the application and the documents submitted.
Volltext	The required expertise of persons who carry out certain work - such as the recovery or take-back of ozone-depleting refrigerants or the inspection and maintenance of equipment containing them - is demonstrated, among other things, by participation in a training course. This training course must be recognized by the competent authority. If you would like to have a so-called advanced training course recognized, you must submit an application to the competent authority. Courses where the training provider is based in Bavaria can be applied for from the Bavarian State Office for the Environment. The application must be made informally and in writing. The place and time of the event must be stated. The documents to be submitted can be found under "Required documents".
