Teaser	The registration committee at the Bavarian Chamber of Architects decides on the entry in the list of external companies.
Volltext	Foreign companies may use the professional titles "architect", "interior architect", "landscape architect" and "urban planner" if they are authorized to do so under the law of their country of origin. Foreign companies that are not entered in a register of companies in the Federal Republic of Germany must give prior notification of the first provision of services. They are listed in a separate register. The registration committee at the Bavarian Chamber of Architects decides on entry in the relevant register.
