Volltext	The European Professional Card (EPC) is an electronic proof that a professional qualification is recognized by another country of the European Union (EU) or the European Economic Area (EEA) or that the requirements for the temporary provision of services in this country have been met. You can check the authenticity of an EPC certificate, e.g. submitted by an employee, online.
