Volltext	<p>Tissues within the meaning of Section 1a number 4 of the Transplantation Act or tissue preparations within the meaning of Section 20c paragraph 1 sentence 1 or sentence 2 of the German Medicinal Products Act (AMG) may only be imported with a permit.
