Teaser	The Free State of Bavaria supports rural districts and rural towns that compensate for deficits in smaller gynecology and obstetrics departments.
Volltext	<p>Purpose and object</p> <p>The purpose of the grant is to support rural districts and towns that compensate for the deficit of a gynecology and obstetrics department at a planned hospital in their area. Overall, the aim is to secure and maintain high-quality obstetric care in hospitals throughout the region</p> <p>Beneficiaries</p> <p>Beneficiaries are administrative districts and independent cities in Bavaria.</p> <p>Type and amount</p> <p>The grant is awarded as a subsidy by way of pro rata financing as project funding.</p> <p>Within the framework of the available budget funds, the rural districts and independent cities receive up to 85% of the amount with which they have fully or partially offset the deficit of a gynecology and obstetrics department located in their area at a planned hospital within the meaning of Art. 5 Para. 2 BayKrG, but no more than one million euros per hospital and financial year, in fulfillment of their obligation to ensure care in accordance with Art. 51</p>

In particular, the following documents must be submitted: Proof of the deficit of the gynaecology and obstetrics department by means of an audited separation statement (in accordance with the requirements of Art. 5 Para. 1 - 4 and 9 of the DAWI Exemption Decree and the provisions of Annex 4 of the Hospital Accounting Decree) Breakdown of the services and revenues of the hospital as well as the obstetrics ward according to statistics E1, E2, E3.2; E3.3 (according to Annex 1 of the Hospital Charges Act) Proof of the compensation of the deficit by the county or the independent city Declaration of the administrative district on the assumption of the deficit in accordance with the DAWI exemption resolution Specification of the relevant data (in particular number of births, registration data of newborns) in accordance with No. 2.3 Guideline for the Promotion of Obstetrics in Bavaria
Voraussetzungen	<p>The prerequisite for funding is a relatively low number of births in conjunction with the status as the main provider in the region.</p> <p>For further eligibility requirements, see the guidelines under "Legal basis".</p>

Verfahrensablauf	<p>The application must be submitted to the Government of Upper Franconia in writing or by e-mail.</p> <p>The Government of Upper Franconia will decide on the application and issue a provisional grant notification. At the end of the approval period specified in the notification, the applicant must submit proof of use within six months. The proof of use will be checked by the government of Upper Franconia. A final decision is then issued with the final grant amount. Once the decision has become legally binding, the grant amount will be paid out.</p>
