Hinweise	Declarations of care can only be made at the Youth Welfare Office (also possible before birth), acknowledgements of paternity are accepted by both the Youth Welfare Office (also before birth) and the registry office in connection with the birth certificate (see link - Birth certificates for newborns -). In principle, all of the certifications required in this context can be carried out at any youth welfare office in Germany. Alternatively, these declarations can also be made to a notary. The same procedure applies to children born abroad, with the difference that the custody register for all these children is kept centrally in Berlin. The contact
