Hinweise	Anyone who is classified as permanently and fully disabled by the specialist committee of a workshop for disabled people (work area) is also entitled to basic security benefits, regardless of age. New from 2020: If social assistance benefits to secure livelihoods are granted in addition to outpatient integration assistance (EGH) benefits, the beneficiary will receive these two benefits from different departments from 2020 onwards. The EGH benefit notification is issued centrally by the Integration Assistance Office in the Wandsbek district (W / EH) and the notification on social assistance benefits is issued by the responsible social welfare office in the district.
