Teaser	If you are moving or are making or expecting deliveries, you can apply for a temporary no-parking zone.
Volltext	For a move, you can apply for a temporary no-parking zone to make the transport as smooth as possible for everyone involved. You can also apply for a temporary no-parking zone for loading and unloading. Depending on local conditions, the road may be closed on one or both sides.
Erforderliche Unterlagen	<ul style="list-style-type: none"> - Main motion - Informal - Provide information in your application - to the location of the temporary no-parking zone - for the planned period - the required length in meters - the length depends on the vehicle used - Proof - Power of attorney if you will be submitting the application on behalf of someone else
Voraussetzungen	You are planning a move or need space on the street for loading and unloading a large vehicle.
Kosten	A fee is charged. The amount depends on the duration and scope of the permit. It is normally between EUR 30 and EUR 200.
Verfahrensablauf	<ul style="list-style-type: none"> - Apply for the temporary no-stopping zone at the responsible authority. - The application will be examined by the competent authority. - You will receive a notification. - If the competent authority approves your application, you will receive a road

	traffic order to install the necessary traffic signs.
Bearbeitungsdauer	Processing is usually immediate or timely.
Frist	Submit the application at least 14 days before the planned move or the planned loading or unloading date. Traffic signs must be put up for residents 3 days before the scheduled date. The duration of the no-parking zone is specified in the permit.

Hinweise	<p>There are the following notes: - The required traffic signs must be put up at least three days before the use of the no-parking zone. The traffic signs may only be put up after receiving the permit, - Only traffic signs in accordance with the Road Traffic Regulations (StVO) may be erected. - The signs can also be installed by an installation service. - You must record the setup in a setup log. There you must note the time and the exact location of the setup. - In case of damage, the applicants may be liable. - Unauthorized vehicles in the no-parking zone can be removed. - Additional measures must be specified in the application; additional permits may be required for this (for example, an application for special use for containers). - You need a separate arrangement for the move-in and move-out locations. - It is not advisable to block off a parking space with ropes, tape, boxes or chairs. Other people looking for a parking space can and are allowed to clear these obstacles and park in them. The police also intervene when they see such barriers. A warning or fine is often issued. - After the move or delivery, you must deactivate the signs. If necessary, return the signs to the location where they were borrowed.</p>
