Handlungsgrundlage	§ 13 Obligations to report and notify - Hamburg Law on Keeping and Leading Dogs - (Dogs Act - HundeG) Schedule of fees for public consumer protection
Teaser	If you want to keep a dog, you are obliged to register your dog.
Volltext	If you own a dog, you must register it immediately. The registration also includes the registration for the dog tax. The information provided by the dog owner is stored in the dog register. Your data will be forwarded to the tax office responsible for dog tax. An additional tax registration is not required. An additional permit is required for dangerous dogs.
Erforderliche Unterlagen	Identity card or passport with the last confirmation of registration Evidence of forgery-proof identification (microchip) Proof of liability insurance with details of the deductible and the sum insured Information about the breed and size of your dog (shoulder height, for puppies the expected shoulder height) if applicable, dog tax exemption notice or notice of reduction
Voraussetzungen	You are the owner of a dog.
Kosten	47 EUR. Reduction to 23.50 EUR possible in individual cases (proof of ALGII, basic security). Online registration 31 EUR The fee reduction is only available for dog tax exemption or dog tax reduction (not for the other dog tax exemptions or dog tax reductions).
Verfahrensablauf	
Bearbeitungsdauer	The processing time is approximately 20 minutes.
Frist	The registration must be made within 2 weeks after starting the dog ownership or in the case of puppies up to the age of 3 months.

Hinweise

You can register your dog at a Hamburg Service location or at your local consumer protection, trade and environment department of your choice, but not in writing or by telephone. In Hamburg, Hamburg Service is the responsible office (for the entire city area). Online registration is also possible, see links. Puppies can also be registered without a chip number; this registration is only possible at the Department of Consumer Protection, Trade and Environment. Registration can also be carried out by an adult, authorized person. Bringing a dog is not necessary. Dogs are not allowed in the offices of the Free and Hanseatic City of Hamburg! Your data will be forwarded to the tax office responsible for dog tax. Additional tax registration is not required. An additional permit is required for dangerous dogs. The fee reduction is only available in the case of dog tax exemption or dog tax reduction according to Section 11 paragraphs 1 to 3 of the Dog Tax Act (not for the other dog tax exemptions or dog tax reductions). Microchip requirement for dogs All dogs aged 3

months and over must be identified with an electronically readable transponder (microchip). The microchip is applied by the local veterinarians. Exceptions can only be permitted for compelling veterinary reasons. Please present a detailed veterinary certificate for this. Foster dogs Foster dogs that stay in Hamburg for longer than two months must be registered. It is irrelevant whether the foster person is the owner or whether the period of stay is not consecutive within a year. Dog liability insurance All dog owners must take out liability insurance. Minimum insured sum: EUR 1 million, excess: maximum EUR 500. The insurance must at least cover the liability of the animal owner. The insurance certificate must clearly state which dog is insured - ideally, the dog's chip number must be entered.
