Teaser	lf you, as a bookmaker, would like to place or arrange bets on public horse races, you must apply for permission in advance.
Volltext	lf you want to place or arrange bets on public horse performance tests as a bookmaker on a commercial basis, you need a permit.
	Permission is granted for
	 the location where bets are accepted or placed and the persons you use to place and arrange bets.
	 Bookmakers can independently conclude betting contracts in their own name and for their own account in public performance tests for horses (e.g. horse racing) or arrange betting contracts for a totalizator or other bookmaker or conclude betting contracts in one's own name but on behalf of others.
	The bets must be offered at fixed odds on the race track for the races taking place on the race day.

	Otherwise, the bookmaker is free to offer the bets at the totalisator rate.
	As a bookmaker, you can have employees (bookmaker assistants) represent you in the exercise of the bookmaking business when arranging and concluding horse bets.
Erforderliche Unterlagen	 Informal, written application for a bookmaking license Form "Attachments to the application for a bookmaker's license" including the evidence and documents specified therein.
Voraussetzungen	 You have proven that you have the necessary personnel reliability. They have proven to have the necessary economic performance and reliability. You have proven that you have the necessary professional skills and experience. You have proven that you have the necessary commercial knowledge.
Kosten	Permission for the public for a bookmaker and for a betting shop for one year each: EUR 500 for each additional betting office for the year: 80 EUR Permission for a bookmaker and for a betting office for the people they want to use to place and arrange bets for one year each:
	150 EUR Permission for a bookmaker to place or arrange bets on a racetrack per day: EUR 25
Verfahrensablauf	 You submit your application to the responsible authority. The responsible authority will examine your application. The decision on your application will be communicated to you in writing.
Bearbeitungsdauer	The processing time depends on the type and scope of the application as well as the quality of the documents submitted.

contradiction
 Anyone who wants to place or arrange bets on public horse races as a bookmaker on a commercial basis requires a licence. To obtain permission, an application must be submitted to the relevant authority. The licence is granted for the location where bets are accepted or brokered and for the persons who accept or broker bets. The permit may be granted with time limits and conditions or may be revoked.
