Volltext	All Germans who have their main residence in Hamburg can apply for a passport. German citizens who are not registered in Hamburg can apply for their passport at the Migration Office of the Ministry of the Interior and Sport. You can get more information by phone or on the Internet. German citizenship is required. Up to the age of 18, the consent of all custodians (parents or guardians) must be available (either through a personal interview or a declaration of consent with a certified signature). The applicant must appear in person. We have to confiscate your old passport or a temporary passport after it has expired. Validity: For people over 24 years of age, the passport is valid for 10 years. It is valid for 6 years for people under the age of 24.
Erforderliche Unterlagen	Current, biometric passport photo, not older than six months. Identity card if available; travel documents if applicable. Additional documents must be brought as required by the relevant passport authority. Important for a passport for minors: To apply for a passport for minors, the consent of the legal guardian is required and a personal appearance is required. If a legal representative cannot be present in person, the consent must be submitted to another passport authority in Germany (residents' office, citizens' office) or to a German diplomatic mission abroad.
