Teaser	Hamburg is characterized by a high diversity of habitats for wild plant species and wild animal species. Almost 10% of Hamburg's land area is under nature protection.
Volltext	Hamburg is characterized by a high diversity of habitats for wild plant species and wild animal species. From running waters to extensively used grassland areas to forests, Hamburg offers a habitat for many species, including rare ones. But parks, tree-lined gardens, roofs and towers can also be important biotopes. Nature conservation not only focuses on rare species such as the dormouse, kingfisher, brook lamprey, white-tailed eagle and peregrine falcon, but also on the development of the biotope network to strengthen the populations of all animal and plant species and the designation of protected areas. In addition, there is the "Hamburgisches Wattenmeer" national park with its protected areas. Further protected areas are planned.
