Responsibility for home admission from the hospital always lies with the department in whose area the home is located if the home application is made by the social service in the hospital and it is thus documented that there is no longer any domestic connection. Outside of Hamburg The local basic security and social services in whose area the applicant last lived are responsible for applying for the costs of an inpatient care facility outside Hamburg. Approval and further processing is carried out by the Eimsbüttel District Office, Department of Basic Social Security and Social Security, Central Assistance Department for inpatient care outside of Hamburg. Home admission in Hamburg / previous place of residence outside of Hamburg The social welfare office of the previous place of residence is responsible for applying for and approving the costs of an inpatient care facility in Hamburg for applicants who have previously lived outside of Hamburg.
