Teaser	<p>If you wish to keep, breed or use vertebrates or cephalopods for experimental purposes or to use their organs or tissue for scientific purposes, you require prior permission from the relevant authority.</p>
Volltext	<p>If you have vertebrates or cephalopods,</p> <ul style="list-style-type: none"> • intended for use in animal testing, or • whose organs or tissues are intended to be used for scientific purposes, <p>If you wish to breed, keep or use animals, you will need prior permission from the relevant authority.</p>

	<p>This also applies if you want to keep or breed these animals for the purpose of giving them to third parties.</p>
Erforderliche Unterlagen	<p>Written application with the following information:</p> <ul style="list-style-type: none"> • Name and address of the applicant • The facilities and establishments serving the activity, including the premises and facilities and the personnel located there. • The type of animals affected and, species-specific, the housing capacities. • The name of the person responsible for the activity. • The presence of persons who care for the animals and are responsible for their killing. • The name of the animal welfare officer. <p>Evidence of the knowledge and skills of the staff must be attached to the application.</p>
Voraussetzungen	<p>You will receive permission if</p> <ul style="list-style-type: none"> • the person responsible for the activity has the professional knowledge and skills required for the activity based on his or her training or previous professional or other contact with animals, • the person responsible for the activity has the necessary reliability. • in the establishments and businesses serving the activity, suitable premises, facilities and sufficiently qualified personnel are available to enable the animals to be kept in a manner that satisfies the requirements of the Animal Welfare Act and the Animal Welfare and Experimental Animal Ordinance. • It is ensured that the persons who care for or kill the animals can at any time demonstrate the necessary expertise. • it can be expected that the necessary organisational, recording and labelling requirements will be met. • one or more animal welfare officers have been appointed for the company • an animal welfare committee was set up. • in the case of primate breeding, the breeder has a concept to increase the proportion of animals that are descendants of primates bred in captivity.

	You must, upon request, provide evidence of the necessary technical knowledge and skills in a technical interview with the competent authority.
Kosten	The permit is subject to a fee. The fees are calculated according to the time spent on the basis of GebOöV 2.1.9.
Verfahrensablauf	<ul style="list-style-type: none"> • Submit your informal application to the responsible authority and attach the required documents and evidence. • The responsible authority will examine your application and, if necessary, request further evidence. • If necessary, the competent authority will carry out an on-site inspection to verify that the permit requirements are met. • The responsible authority will decide on your application. • You will receive a notice from the responsible authority.
Bearbeitungsdauer	The processing time varies greatly depending on the scope of the activity applied for, but is usually a few weeks. The processing time is 4 months from receipt of a complete application. The processing time can be extended by 2 months in difficult cases.
Frist	You may only begin the activity you have applied for once you have received permission to do so. The responsible authority will decide on the application within 4 months of receiving a complete application. In difficult cases, an extension of 2 months is possible. The permit is usually granted for an unlimited period.
