Voraussetzungen	You are the owner of a dog and are moving within Hamburg.

Verfahrensablauf	You inform the responsible authority of your new address. The responsible authority will check your notification and add it to its dog register.

Frist	Report your new address to the relevant authority within two weeks of your move.
