on the basis of the purchase contract. The sales contract is usually sent by the notary to the tax office for transfer taxes and real estate. The subsequent entry in the land register is also usually handled by the notary. For this purpose, he or she submits a corresponding application to the competent court, enclosing a clearance certificate. Questions about child benefit will be answered by the Kreditanstalt für Wiederaufbau (KfW) or on their website.
