In addition, voluntary (free of charge) notifications can be made (e.g. name changes or changes of name, changes in management, changes to the private addresses of the tradespeople or the managing directors; partial abandonment of the business item). the Chamber of Commerce or the Chamber of Crafts, the respective trade association, the state office for occupational safety.
