Volltext	The fees for child day care are also called the family contribution or participation fee. They depend on the net family income and the size of the family as well as the benefit used. The fee tables, the Kita fee calculator and the application to reduce the fee are available on the Internet (see links). Since August 1, 2014, the five-hour basic care in the day care center (and in day care) has been free of charge for all children from birth to school enrollment. Parental contributions are reduced accordingly for childcare times that go beyond this. Parents do not need to take any action if they already have a current child day care permit. The changed contributions are automatically applied by the district offices; no separate application is required.
