Advice takes place in face-to-face meetings that can be arranged over the phone. Authentication of the signature on health care proxy and care directives are offered. The counseling center offers advanced and advanced training courses for volunteer supervisors and authorized representatives. Information events as well as multiplier training for institutions and authorities are also offered.
