Volltext	The type of violation and the standard rates for warnings and fines are specified in the nationwide catalogue of offenses. When dealing with traffic violations, a distinction must be made between the detection of traffic violations (mainly by the police) and their punishment by the fines office. Administrative offences up to 55 euros are punished

	payment deadline for the warning is one week after receipt. If payment is not made on time, a fine notice will be issued. If the proceedings are not discontinued after a statement or objections are submitted, a fine notice will also be issued.
	For administrative offences worth 60 euros or more, the proceedings are initiated in writing by hearing the person concerned (if the police were not heard on site) and the punishment is imposed by issuing a fine. It is advisable to read the information on the back carefully. A fine is not a warning, but a decision that can be appealed against and an appeal can be lodged within two weeks of being served. The appeal period must be observed.
	Appeals must be lodged via fax, De-Mail or letter post.
	In Hamburg, the Office for Migration, Department for Traffic Fines, of the Ministry of the Interior and Sport is the responsible department.

All payment data can be automatically accessed via the corresponding apps.**</li> <li>**Handing over driving license**</li> <li>Driving licenses are only accepted in the case of driving bans from the Hamburg Fines Office.</li> <li>Submission is possible by post or by dropping it in the house mailbox, stating the file number.</li> <li>The driving ban begins when it is received by the fine office. No driving licenses will be accepted if the driving ban is not from the Hamburg fine office.</li> <li>The driving licenses will be sent back to the affected persons by post in good time before the deadline expires.</li> <li>**Contact**</li> <li>The traffic fine office cannot be reached in person.</li> <li>Reference is made to the online hearing (see cover letter), email, fax and letter post.</li> <li>A lot of information can also be found on the website.</li> <li>Hamburg Fines Office - hamburg.de</li> </ul>
