Volltext	Entry / transit - Schengen countries Students from third countries (non-EU countries) who have a residence permit in Germany (settlement permit or residence permit) do not need a visa for the Schengen states. This applies to both transit and stays of up to three months. The prerequisite is that they have a valid national passport from their country of origin and a German residence permit. Entry / transit through EU member states, but not Schengen states For entry into and transit to an EU member state that is not a Schengen state, the student collection list was developed for class trips of general schools and vocational schools. Students from third countries no longer need a visa for entry / transit if they are entered on such a list. If the student collection list is provided with passport photos, it even replaces the passport.
