Teaser	I recommend that you provide a consent form from you for your minor child who is travelling abroad without parents.
Volltext	If a child travels abroad without being accompanied by his or her parents or one of his or her parents, he or she should be given an informal consent form in addition to the required identification documents. This must state that the legal guardian(s) agrees to the trip abroad. The consent form should contain the following information: • Personal details of the child, • Personal details and contact details of the legal guardian, • Itinerary and • if applicable, the personal details of the adult accompanying person(s).

In case of a name difference, the child should also provide a copy

- his birth certificate and
- the ID data page of the legal guardian

carry with them.

Depending on the destination country,

- signatures of the consent form must be certified,
- the consent form must be in the language of the respective target country to be translated,
- a translated court custody decision is required.

You can have the translations done at a translation agency of your choice let.

A notice:

Some countries do not allow children traveling with only one parent with custody to enter the country without a consent form from the other parent with custody.

You can also find special features of individual destination countries in the travel and Safety instructions from the Federal Foreign Office. For further information on the respective regulations of the destination country, you can also contact the responsible foreign representation in the Federal Republic of Germany.

Informal declaration of consent, as well as a copy of the identification data page of the legal guardian.

Note: Depending on your destination, costs may apply for required certifications and/or translations.

Verfahrensablauf

You can write the consent form for minors informally. You do not need to submit an application.

Hinweise

If both parents have custody and one parent wants to travel abroad alone with the child, the other parent should also provide such a consent form. This makes it easier for border authorities to distinguish normal travel with the child from attempted child abductions.

Rechtsbehelf

Kurztext

Declaration of consent for minors travelling without a legal guardian or with only one legal guardian

- Declaration shows that the parent or parents are in agreement with the trip abroad agree
- Content of certificate:
 - Personal details of the minor child
 - Personal details and contact details of the legal guardian
 - if applicable, the personal details of the adult accompanying person(s)
 - Itinerary
- Responsible: Federal Foreign Office
