Applicants for the issue or extension of a driving license of classes C, C1, CE, C1E, D, D1, DE, D1E as well as the driving license for passenger transport must be examined whether there are illnesses that exclude the suitability or the conditional suitability. You have to provide proof of this. Applicants for the issue or extension of a class D, D1, DE, D1E driving license and a driving license for passenger transport must also meet special requirements with regard to: b. Orientation service, c. Concentration performance, d. Attention performance, e. Responsiveness fulfill. The methods used to investigate these characteristics must be standardized according to the state of the art and validated under aspects of road safety. Proof of the fulfillment of these requirements is to be provided, taking into account the principles according to Annex 15, by submitting an operational or occupational medical opinion according to § 11 Paragraph 2 Clause 3 No. 3 or an opinion from an officially recognized assessment body for fitness to drive. of applicants for the issue of a driving license of classes D, D1, DE, D1E and a driving license for passenger transport, from applicants for the extension of a driving license of classes D, D1, DE and D1E from the age of 50, from applicants for the extension of a driver's license to transport passengers from the age of 60.
